SUBJECT: Financial Audit of USAID Resources Managed by Zimbabwe Health Interventions

Under Multiple Awards, October I, 2023, to September 30, 2024 (Report No. 4-

613-25-122-R)

This memorandum transmits the final audit report on USAID resources managed by Zimbabwe Health Interventions (ZHI) under: (I) Accelerated and Comprehensive HIV Care for Epidemic Control in Zimbabwe (ACCE), cooperative agreement 72061321CA00007; and (2) Re-Ignite, Innovate, Sustain and Empower (RISE) program, cooperative agreement 72061321CA00010. ZHI contracted with the independent audit firm BDO, Harare, Zimbabwe to conduct the audit. The audit firm stated that it performed its audit in accordance with generally accepted government auditing standards (GAGAS). However, it did not have an external peer review and a continuing professional education program that fully satisfy the standards' requirements. The audit firm is responsible for the enclosed report and the conclusions expressed in it. We do not express an opinion on ZHI's schedule of expenditures of USAID awards; the effectiveness of its internal control; or its compliance with the award, laws, and regulations. I

The audit objectives were to (I) express an opinion on whether the schedule of expenditures of USAID awards for the period audited, was presented fairly, in all material respects; (2) evaluate ZHI's internal controls; (3) determine whether ZHI complied with award terms and applicable laws and regulations; (4) review the indirect cost rate; and (5) review the implementation status of the prior period recommendations.

To answer the audit objectives, BDO (I) audited the schedule of expenditures of USAID awards including the budgeted amounts by category and major items and the revenues received from USAID for the period covered by the audit and the costs reported by ZHI as incurred from October I, 2023, to September 30, 2024; (2) evaluated the control environment, the

adequacy of the accounting systems, and control procedures that pertain to ZHI's ability to report financial data consistent with the assertions embodied in each account of the schedule of expenditures of USAID awards; (3) identified the award terms and pertinent laws and regulations and determined which of those, if not observed, could have a direct and material effect on the schedule of expenditures of USAID awards; (4) determined the review of the indirect cost rate was not applicable; and (5) reviewed the implementation status of the prior period recommendations. ZHI reported expenditures of \$24,498,636 in USAID funds during the audited period.

The audit firm concluded the schedule of expenditures of USAID awards presented fairly, in all material respects, program revenues and costs incurred under the awards for the period audited. The audit firm identified no questioned costs; no material weaknesses in internal control; and no instances of material noncompliance. In addition, although we are not making a recommendation for significant deficiencies noted in the report and management letter, we suggest that USAID/Zimbabwe determine if the recipient addressed the issues noted.

Accordingly, we are not making any recommendations.

OIG does not routinely distribute independent public accounting reports beyond the immediate addressees because a high percentage of these reports contain information restricted from release under the Trade Secrets Act, 18 U.S.C. 1905 and Freedom of Information Act Exemption Four, 5 U.S.C. 552(b)(4)("commercial or financial information obtained from a person that is privileged or confidential"). In addition, USAID OIG has determined that this transmittal memo and the enclosed report are not subject to notification and reporting requirements under Section 5274 of the National Defense Authorization Act.²
